With 16 producer credits to his name, Pat Wintersgill knows all about the highs and lows of film production.


"So many things can go wrong," he says, "but when they all go right, that's an amazing feeling! To create something that's there – and will always be there – and to share it on the big screen –

While the boutique post house Film Shed – "Stories personally tuned in colour and sound" – prides itself on being in the trenches with its client filmmakers, Pat's parallel role as producer sees him involved from the earliest planning stages.

Set-up delays increase the risk of failure

One of film producers’ biggest challenges is keeping the whole project on track, especially in the critical early stages.

“Whenever anything goes a bit off track, there is the risk of total failure,” Pat explains. “A source of finance could pull out, an actor could pull out, a location could pull out. And then, as producer, you’re the one who’s got to fix it. The buck stops with you, so you’ve got to find a way through.”

Timing is critical and often dependent on cash flow. Delays in setting up the SPV or opening bank accounts can create cash flow problems right from the beginning.

“It’s one of the worst things that can happen. You start losing key people and the whole project is jeopardised, especially on the shoot.

Your schedules are cast-dependent, especially if you have a high-profile actor. You’re only going to get them for those six weeks, or however long you’ve got them for. If you don’t shoot them in those six weeks, they’ll be onto a different project and then you’re scuppered. If you have delays with your bank account and your cash flow, you won’t be able to keep the whole thing together. You’ll lose crew members. You’ll lose location suppliers. The whole thing will just disintegrate.”

Having experienced stressful delays on previous projects, Pat was looking for a better solution.

Assembling the finance for a film project can be complicated. Centtrip’s position as a regulated institution with expertise in the needs of the film industry can help.

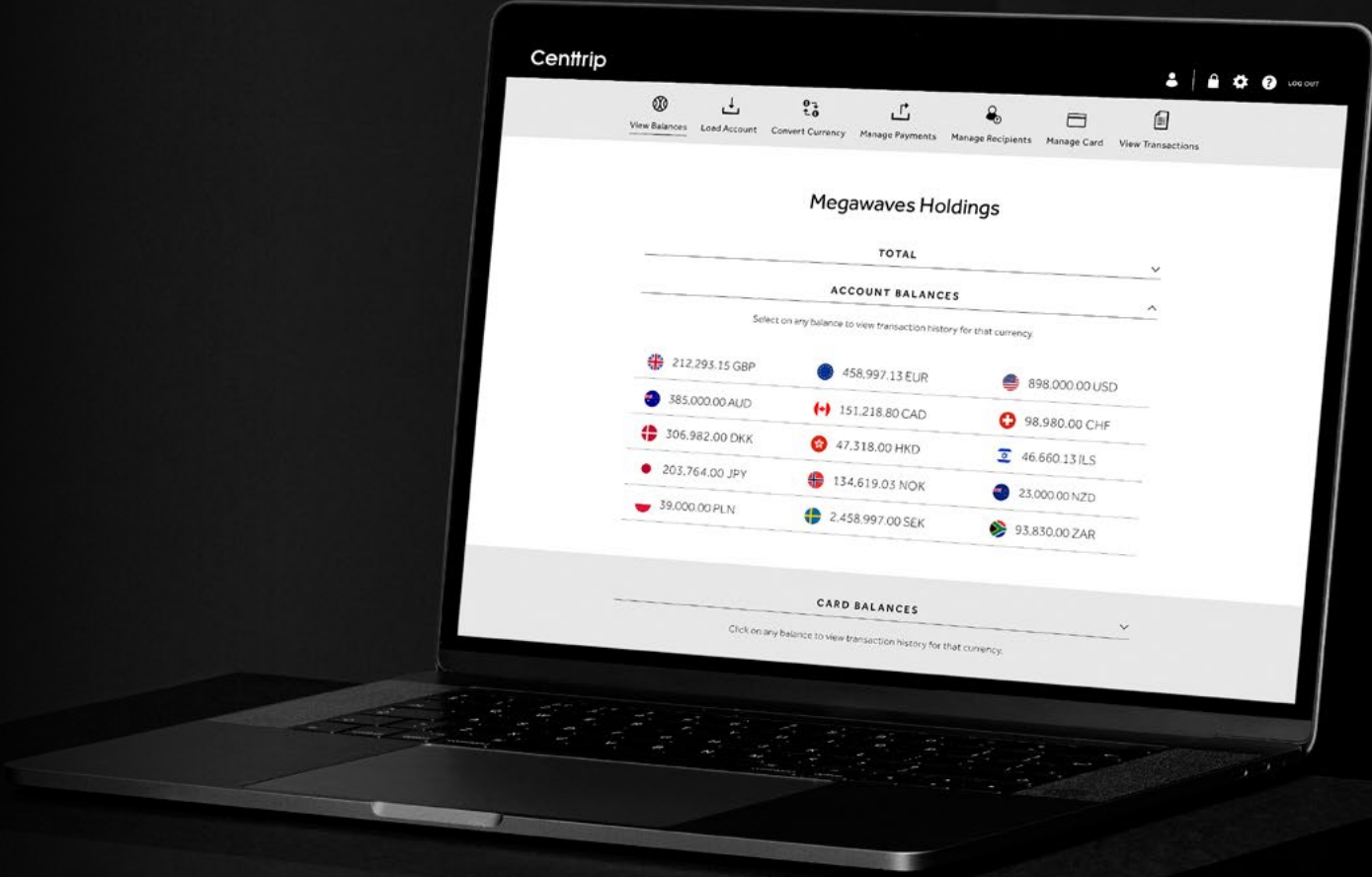
